As a member or retiree of International Brotherhood of Teamsters Local 295, you have a no-cost **\$4,000 Accidental Death & Dismemberment** benefit. These benefits have been provided through the cooperation of International Brotherhood of Teamsters Local 295 and National Income Life Insurance Company, a New York State based 100% union company.

National Income Life currently has over 82,000 New York IBT members covered under AD&D policies at no cost. Since 200, over \$7.3 million in life, health, and no-cost AD&D benefits has been paid to over 14,000 New York IBT members and their families.

Please return the card enclosed so you may receive your certificate of coverage and name your beneficiary. New York State law requires that each member be allowed to receive their certificate of coverage and properly name their beneficiary. If you do not name your beneficiary the \$4,000 would be paid to your estate and may be taxable.

You can also receive Child Safe Kits for your children and grandchildren at no cost. These kits help you gather vital data, photos and fingerprints for authorities in the event of an emergency.
